#### Training Opportunity through National Workforce Development

"Every great leap forward in your life comes after you have made a clear decision of some kind."

This pool of funds issued by the Australian Government is available to assist enterprises and industry sectors to increase their workforce capacity by providing employers and workers with the opportunity to enhance their skill levels through formal training.

Organisations can nominate qualifications from Certificate III to Diploma level. Identify a skill set that your organisation needs to address and how your business will be able to measure the effectiveness or impact in the business.

Employers are required to co-contribute to the agreed cost of training at:

- 33% if they have up to 99 fulltime staff
- 50% if they have100-199 fulltime staff
- 67% if they have >200 fulltime staff

The National Workforce Development Fund will pay the balance.

Candidate criteria includes citizenship and/or permanent residency.


