

Smart and Skilled Student Fees

Under Smart and Skilled, a student contributes towards the cost of training through the payment of a student fee. Student fees are set for the whole qualification (not annual or semester fees), and regulated across the state of NSW. That means that all Training Providers are required to charge the same fees.

Traineeships Student fees are regulated as:

- \$870 for each Certificate II level qualification
- \$1000 for each Certificate III, IV or Diploma level qualification

This fee, in most cases, is paid by your employer when they commit to the Traineeship. You have responsibilities in return and have the opportunity to complete the qualification through your employer.
